

SUMMARY ANNUAL REPORT FOR AMERICAN BUSINESS SOLUTIONS IN 401 K PROFIT SHARING PLAN TRUST

This is a summary of the Form 5500-SF Annual Return/Report of Small Employee Benefit Plan for the AMERICAN BUSINESS SOLUTIONS IN 401 K PROFIT SHARING PLAN TRUST, EIN 31-1604561, Plan 001, for period January 1, 2025 through December 31, 2025. The Form 5500-SF annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a defined contribution, age/service weighted or new comparability, profit-sharing, ERISA section 404(c), total participant-directed account, Code section 401(k), default investment account, pre-approved, single employer type of plan.

Basic Financial Statement

Plan expenses were \$932,355. These expenses included \$2,000 in administrative expenses and \$930,355 in benefits paid to participants and beneficiaries. A total of 117 persons were participants in or beneficiaries of the plan at the end of the plan year.
